The CEI is a national benchmarking survey and report on corporate policies and practices related to LGBT workplace equality and is administered by the Human Rights Campaign Foundation. Caesars joins the ranks of 517 major U.S. businesses that also earned top marks this year.

"Over the past 10 years, Caesars has come a long way in its quest for basic human rights, particularly the rights of the LGBT community," said Jan Jones Blackhurst, Executive Vice President of Government Relations & Corporate Responsibility at Caesars. "Caesars is proud of this recognition by the Human Rights Campaign, and to be a leader in championing diversity and equal rights for everyone."



The 2017 CEI rated 1,043 businesses in the report, which evaluates LGBT-related policies and practices including non-discrimination workplace protections, domestic partner benefits, transgender-inclusive health care benefits, competency programs, and public engagement with the LGBT community. Caesars' efforts in satisfying all of the CEI's criteria results in a 100 percent ranking and the designation as a Best Place to Work for LGBT Equality.
